

Western Asset Income Fund Declares Monthly Dividend Distribution for March 2009

Pasadena, CA - March 2, 2009 - Western Asset Income Fund ("Fund") (NYSE:PAI) announced today the declaration of its monthly ordinary income dividend of \$0.0800 per share on its Common Stock. The monthly dividend will be paid on March 31, 2009 to shareholders of record as of March 13, 2009. The ex-dividend date will be March 11, 2009.

The Fund is a closed-end investment company that invests predominantly in a diversified portfolio of debt securities. Its investment adviser is Western Asset Management Company; a subsidiary of Legg Mason, Inc. Western Asset Management Company has managed the Fund since its inception in March 1973.
